Therapeutic Guidelines

Therapeutic Guidelines Ltd (TGL) recently announced that from April 2019, new versions of guidelines would only be published in digital format in *eTG complete*. This means the complete set of guidelines is *only* available in eTG complete; whilst TGL will still have up to date book versions of some of their guideline titles, the complete set of books is no longer available for purchase.

As all pharmacy premises in Western Australia must comply with Schedule 1 of *Pharmacy Regulations 2010 (WA)*, the Minimum standards of fitness for the competent and safe practice of pharmacy (Minimum standards), this means that any pharmacy that does not subscribe to the eTG complete, will not be in compliance with the Minimum standards.

The Board recommends any pharmacy premises that does not currently subscribe to the eTG complete, purchases a subscription as soon as possible.

The Board has also been in discussions with TGL, who have kindly offered, *for any new single-user subscribers*, **a 20% discount** on the usual cost of an eTG complete annual subscription. For those people who have bought a hard copy of Diabetes version 1, 2019 and Ulcer and Wound Management version 2, 2019, TGL will also offer an additional discount on top of the 20% discount (both discounts apply to 30 May 2019).

Registration Renewal Applications – 2019/2020

In the next few weeks, the Pharmacy Registration Board of Western Australia (**the Board**) will be sending out Registration Renewal Application Forms (**Application**) **by email** to all pharmacy premises.

This year's renewal applications will be accessed and submitted online, with all Responsible Pharmacists to make an online declaration that they comply with the *Pharmacy Act 2010 (WA)* and *Pharmacy Regulations 2010 (WA)* (including the Minimum standards).

Renewal Application payments are to be made online, via credit card. The Board is also in discussions with BPay, to allow payments via bank accounts. We will update you as soon as this becomes available. As 30 June 2019 falls on a Sunday, the Board strongly suggests that all declarations and renewal application payments be made no later than Wednesday, 26 June 2019, in order for the Board to receive these by Friday, 28 June 2019, to ensure your pharmacy registration is renewed to 30 June 2020.
