FUNCTION OF THE BOARD

The Pharmacy Registration Board of Western Australia is a Statutory Body appointed by the Minister to administer the Pharmacy Act 2010. The functions of the Board are prescribed under the Act as:

- I. to advise the Minister on matters to which the Act applies;
- II. to administer the scheme of registration;
- III. to monitor, and enforce, compliance with the Act;
- IV. to perform other functions that are conferred on the Board under the Act or any other Act.
