Updated Guidelines for Plans of Registered Premises Document and Changes to Operational Procedures Requirements

There have been a number of pharmacies undertaking significant alterations to their premises. The Board considers the introduction of one or multiple consultation rooms to be of benefit to the health of the WA public. With this in mind, the PRBWA has reviewed its processes for providing plans for registration of new pharmacies and undertaking significant alterations for premises to make is simpler for the applicant to complete.

What is a significant alteration?

When reviewing the pharmacy premises audit reports we have found some cases of pharmacies undergoing significant alterations without PRBWA approval.

Significant alterations include any of the following:

- Alterations to the perimeter of the premises
- Alterations affecting public access to the premises
- Alterations to the dispensary including changes to the perimeter and access to the dispensary
- Addition of a compounding room or DAA area separate to the dispensary
- Addition of a consulting room
- Alterations to counselling areas

The list is not exhaustive. All applications are considered on a case-by-case basis. If clarification is required please contact the PRBWA on Applications_Admin@pharmacyboardwa.com.au. Ask before you start any renovations or alterations.
