This issue of Blueprint is reserved for revision of the three R's of the Pharmacy Registration Board of Western Australia—<u>Registrations</u>, <u>Renewals</u> and <u>Reviews—from establishment on 18 October 2010 to 31 August 2011.</u>

- ❖ Act refers to the "Pharmacy Act 2010"

Registrations

In response to constructive feedback from pharmacists -

- the single form covering all types of applications to the Board is being revised with a view to developing a separate form for each type of application.
- * the Notification of Completion of New Pharmacy Premises and Notification of Completion of Alterations/Extensions to Existing Registered Pharmacy Premises forms are being revised.

After nearly twelve months of operation, the Board -

has revised the requirements for plans of premises that are necessary attachments to some types of applications.

The three R's (continued)

Registrations (cont'd)

- recommends pharmacists considering purchasing a pharmacy ensure that the premises is in complete compliance with relevant legislation prior to transfer of ownership to safeguard against inheriting noncompliance issues at the premises.
- * recommends pharmacists considering purchasing a pharmacy ensure that the premises are in accordance with the plans held by the Board to safeguard against having to make substantial alterations to ensure compliance with the Act. To assist a purchasers due diligence, the Board will check any submitted premises plans against the plans registered for that premises.
- reminds all *pharmacists* to be aware that it is an offence to provide false or misleading information with respect to the application process for registration of premises.

Renewals

In response to constructive feedback from pharmacists -

- the statements and questions on the Registration Renewal Statutory Declaration required to be completed for registration will be revised.
- future declarations will include guidance on who is authorised to witness statutory declarations. For your immediate reference, a list is available on the Department of the Attorney General, Court & Tribunal Services website. The website address is http://www.courts.dotag.wa.gov.au; the list can be accessed by going to "Justices of the Peace" then choosing "Witnessing documents."

Following the inaugural processing of registration renewal forms and declarations, the Board questions whether -

- * pharmacists answered the following question on the 2011/2012 Registration Renewal Statutory Declaration correctly? "Are there any other businesses other than that of a pharmacy business conducted from the registered premises? If so please provide details of the other businesses and the ownership structure for each." When renewal forms were issued, the Board was aware of other businesses conducted at various premises and notes that the above question may not have been accurately completed on some declarations. For example, if another business such as a newsagency, nurse practitioner clinic or post office agency is conducted, or other services are operated under a franchise arrangement such as a weight loss program or diabetes agency then the details and ownership structure for each was required.
- pharmacists answered some questions without checking the compliance of the premises with the Regulations? Despite only one of 544 pharmacists indicating that the premises were not in full compliance with the Regulations, subsequent inspections have shown otherwise.
- pharmacists were aware that they are responsible for fully completing and signing all registration renewal forms and declarations required as part of the annual renewal process for registration of pharmacy premises? Many renewal forms returned for processing were not signed by the pharmacist.
- * pharmacists were aware that declarations required to be completed for registration are made under the Oaths, Affidavits and Statutory Declarations Act 2005 and they must sign the form in the presence of an authorised witness? The signature on many renewal forms returned for processing were not witnessed by an authorised witness.

The three R's (continued)

Renewals (cont'd)

The Board reminds all *pharmacists* to be aware that it is an offence to provide false or misleading information with respect to the annual renewal process for registration of premises.

Finally, the Board regrets the misprints on the 2011/2012 renewal registration forms.

Reviews (Inspections)

The first issue of *Blueprint*, published in March 2011, introduced pharmacist Julie Turich as the Board's compliance officer and advised that one of the responsibilities of this position is to inspect metropolitan and regional pharmacy premises to monitor their compliance with relevant legislation.

Pharmacy inspections commenced in March 2011 and a compliance program was introduced on 1 July 2011. Following inspection of nearly ten percent of premises with an emphasis on compliance with Schedule 1, the Board acknowledges and appreciates the overall cooperation of pharmacists during and following inspection.

With respect to the inspection process, all pharmacists should be aware that -

- the Board may enter any premises during opening hours and inspect the pharmacy or anything in or on the pharmacy to ensure that the pharmacy meets the requirements prescribed by the Schedule 1; Pharmacy Act 2010, section 44 (1).
- ❖ a pharmacist practising at premises, and a person in whose name the premises are registered, are to provide all reasonable assistance to a person entering and inspecting a pharmacy; Pharmacy Act 2010, section 44 (2).
- ❖ a record of inspection for consideration by the Registrar and/or Board is completed during inspection of the premises. Following consideration, written correspondence is forwarded to the *pharmacist* documenting the outcome of the inspection. The correspondence will either confirm compliance of the premises with relevant legislation or contain a notice of non-compliance which details the issues to be addressed as a result of the inspection and specifies a time frame for receipt of a written reply from the *pharmacist*.
- ❖ some replies to notices of non-compliance have been either incomplete, difficult to interpret or forwarded in a piecemeal manner. Therefore, the Board is introducing a standard procedure for submission of written replies and requested attachments. Shortly, a reply paid envelope will be included with post inspection correspondence to ensure return via post of a written reply, on a pharmacy letterhead, prepared and signed by the *pharmacist*, with requested attachments.
- either print or electronic copies of requested attachments are acceptable. However, to accommodate the Board's electronic filing system, copies sent via email cannot be accepted. Copies can be submitted electronically by saving descriptively named documents to an appropriate electronic storage device and including it in the reply paid envelope. Please note that if you are including an electronic storage device, would you please ensure it's wrapped in some type of bubble wrap to prevent breakage.
- * all replies to correspondence from the Board should be delivered within the specified time frame.
- ❖ to date, no inspected premises have been in complete compliance with Schedule 1.

The three R's (continued)

Reviews (Inspections) (cont'd)

- * the Board is of the opinion that it is reasonable to expect that a professional person has a basic knowledge and understanding of the legislation that regulates their profession. Therefore, the Board recommends that proprietors of premises and *pharmacists* familiarise themselves generally with the Act and Regulations and particularly with Schedule 1.
- since 18 October 2010, only new premises or premises undergoing a significant alteration are required to comply with Schedule 1 with respect to having a dispensary that has a minimum floor area of 10 square metres and an area in which a consultation conducted by a pharmacist is not reasonably likely to be overheard by a person not a party to the consultation.

Routine Recommendations for Readers

- * All pharmacists familiarise themselves generally with the contents of the Board's website and particularly with the Register of Registered Premises. The website address is http://www.pharmacyboardwa.com.au; the Register of Registered Premises can be accessed by going to "Premises Register."
- ❖ All applications to the Board are completed in full and contain all relevant documents as attachments.
- All types of applications are submitted by the nominated time prior to a scheduled Board meeting to ensure inclusion on the Agenda for that meeting.
- ❖ An appointment is required to meet with personnel who report to the Board, the Board's Registrar, Assistant to the Registrar and Compliance Officer.
- ❖ The current *Certificate of Registration as a Pharmacy* is displayed on the premises so that it can be viewed by consumers.
- All pharmacists develop quality control procedures designed to ensure that the premises are in complete compliance with relevant legislation at all times.

Regulations for Reader's Reference

All pharmacists should be aware that -

- if there is any change to the information recorded in the register in respect of a pharmacy, the person in whose name the pharmacy is registered must, within 14 days of the change, give notice of the change in writing to the Board and attach the relevant fee to change information recorded in the Register; Regulations, regulation 9.
- * a person must not sell or supply a tobacco product at a registered pharmacy; Regulations, regulation 12.
- they must not cause or permit any significant alteration to be made to the pharmacy without prior written approval of the Board; Regulations, regulation 14 (1). A significant alteration is an alteration to the pharmacy that affects the construction, structure, layout or floor area of the pharmacy; Regulations, regulation 11.
