The Board encourages you to download and review its updated guidelines: "Guidelines for Professional Services Room – Administering Vaccines and Other Injections." This document is available on the Board's website. Following these Guidelines ensures that pharmacists help build public confidence in pharmacist-delivered care and maintain safety within expanded vaccination services.

If you currently offer or plan to offer injection services, review the Guidelines carefully to verify that your professional services room meets all requirements. Act now to ensure compliance, as all **pharmacy injection services must meet these requirements by 1 January 2028**.

We also encourage you to consider the requirements outlined in the Guidelines when preparing future applications to:

- Establish a new pharmacy business,
- Relocate an existing pharmacy to new premises, and
- Undertake significant alterations to an existing pharmacy.

Ensuring compliance from the outset will help streamline the approval process and support safe, professional service delivery.
