Welcome to the Board's latest Communiqué.

### **2026 Registration Renewals**

The Board advises pharmacists with overall responsibility that the online Application Form has now been delivered to your inboxes.

Please note that your application must be fully completed, and the relevant fee paid, by **30 June 2026**. This is required for the pharmacy to remain operational on **1 July 2026**.

Failure to meet these requirements will result in the pharmacy being required to close.

Pharmacists are also reminded that statutory declarations submitted as part of this process are made under the *Oaths, Affidavits and Statutory Declarations Act 2005 (WA)*, with charges and penalties set in the *Criminal Code Act Compilation Act 1913 (WA) Criminal Code*. Making a false or misleading declaration is a serious offence and may result in; imprisonment, significant legal penalties, civil liability for fraudulent misrepresentation, as well as potential professional disqualification.

### **Correspondence Guidelines**

To assist in the efficient processing of requests and to minimise delays, please ensure that all correspondence submitted to PRBWA meets the following requirements. The Board is currently experiencing significant administrative time addressing incomplete or unclear submissions.

Effective immediately, all emails must include:

#### **Email Subject Line**

Please include all of the following:

- Pharmacy registration number (for new pharmacies, you may leave this blank until you are allotted a registration number)
- Pharmacy business name
- Clear and descriptive subject

#### **Email Body Content**

- Provide clear context for your request
- Include a brief explanation outlining the purpose of your correspondence

#### **Document Requirements**

- Documents must be submitted in PDF format
- Documents must be:
  - Clearly legible
  - Correctly oriented (not upside down or sideways)
- Photos of documents will not be accepted

## **Multiple Pharmacies**

- Where you own or represent more than one pharmacy:
  - Submit separate emails for each pharmacy
  - Ensure each email relates to one pharmacy only

Adherence to these requirements will assist the administration team in processing requests efficiently and support timely outcomes.

## **Public consultation on endorsement for scheduled medicines**

We would like to bring to your attention an important development that may have a significant impact on pharmacy practice and your professional responsibilities.

The Pharmacy Board of Australia has commenced public consultation on a proposed framework relating to:

- Registration Standard: Endorsement for scheduled medicines, and
- Guidelines: Endorsement for scheduled medicines

These proposed changes are designed to support an endorsement pathway that will influence how pharmacists' access and utilise scheduled medicines in their scope of practice. As such, the outcome of this consultation may considerably shape future professional requirements, training expectations, and practice opportunities.

Your input is vital to ensure the final standards are practical, evidence-based, and reflective of the realities of pharmacy practice.

## **Application Documentation Requirements**

Further to our communication issued in November 2025 regarding application documentation requirements, the Board has conducted an additional review of its administrative processes.

Despite the previous guidance provided, the Board continues to receive applications containing incomplete, incorrect, or non-compliant documentation. This places a significant administrative burden on staff and impacts the timely and efficient processing of applications.

Accordingly, the Board has determined that the current allowance for submission of outstanding documentation up to one week prior to a meeting does not provide sufficient time for proper review.

### **Effective immediately, the following requirements apply:**

- All application documentation must be complete, compliant, and fully executed (where required) by the published cut-off date listed on our website.
- Late submissions or outstanding documents received after the cut-off date will no longer be accepted.
- Applications that remain incomplete at the cut-off date will be deferred until all required materials have been submitted in full.

To minimise delays or deferrals, applicants are strongly encouraged to submit documentation well in advance of the cut-off date. Early submission allows sufficient time for administrative review and for any required amendments to be made prior to the deadline.

The Board appreciates your cooperation in ensuring that all submissions meet these updated requirements.
